Alaska Native Vietnam-era Veterans Land Allotment Program of 2019

Application Process

Eligible veterans and heirs can select up to 160 acres of land until Dec. 29, 2025 under the Dingell Act's 5-year-long Alaska Native Veterans Land Allotment Program of 2019.

Here's the process for applications we receive:

6 Steps | application to Certificate of Allotment

Application Received & Reviewed

If application is incomplete, then the applicant is in

If application is incomplete, then the applicant is notified of missing information. The application processed when missing information is received.

- Selection Recorded & Applicant Notified
 - Applicant's allotment selection is noted on the live Available Lands Map, Master Title Plat & Historical Record
 - Applicant is notified that selection is noted to the record
 - Draft Survey Conducted & Applicant Notified
 - A survey plan is drafted based on the applicant's allotment selection.
 - The draft survey and a Notice of Plan to Survey are sent to applicant, who has 60 days to disagree or change the original selection in writing.
 - This is the last opportunity applicants have to change the original selection.
 - Survey requested after 60 days if no change or response from applicant
 - The survey is ordered automatically after 60 days if no change request or response is received from the applicant.
 - Land selection cannot be changed after survey is ordered.
 - Surveying can take some time based on Alaska's limited field season and roads, but BLM anticipates the first surveys beginning by late 2021.
- Survey completed and Notice of Survey sent to applicant.
 - The applicant has 60 days to agree or disagree in writing.
- Certificate of Allotment issued

 A certificate is issued to the applicant 60 days after the Notice of Survey if no response or change request is received.
